World of Workwear (Pty) Ltd Customer Data Protection Addendum: 01 July 2021

This Addendum ("**Addendum**") shall be effective as from 1 July 2021 ("**Effective date**").

With reference to the existing contract/s ("**Agreement/s**") that you ("**the Purchaser**") have in place with World of Workwear (Pty) Ltd ("**the Company**"), the parties to this Addendum hereby agree to the incorporation of the terms and conditions set out below into the said Agreement/s:

The Protection Of Personal Information Act - POPIA

1. The Purchaser is hereby notified that its personal information and, if applicable, that of its representative/s and other parties provided to the Company herein or otherwise, will be collected and processed by the Company as envisaged in the POPI Act, primarily for the purposes of enabling the Company to consider the Purchaser's application for credit facilities with it and to conclude agreements with the Company in respect of the supply of goods.
2. The Company is the responsible party in respect of such personal information, as envisaged in the POPI Act, and its address and contact details appear in the credit application the Purchaser agreed upon when entering the agreement with the Company.
3. The Purchaser acknowledges that:
 - a. The furnishing of such personal information is voluntary and not mandatory; and
 - b. The consequence of failure to provide such personal information could lead to the inability of the Company to consider the Purchaser's application for credit facilities with it and/or the inability of the Company to conclude agreements with the Purchaser in respect of goods sold on credit.
4. The Purchaser acknowledges and confirms that the Company may process their information, including information regarding identity and/or registration numbers, e-mail addresses, physical and/or postal addresses, telephone numbers and full names.
5. The processing of information by the Company includes the collection, storage, updating, use, making available and/or destruction thereof, so as (amongst others) to enable the Company to:
 - a. Consider the Purchaser's application for credit facilities with it.
 - b. Conclude agreements with the Purchaser in respect of goods.
 - c. Enforce and/or collect on any agreement when the Purchaser is in default or breach of this Agreement's provisions and/or to trace the whereabouts of the Purchaser for purposes of such enforcement and/or collection.
 - d. Perform historical, statistical and/or research functions.
 - e. do affordability assessments, credit assessments and/or credit scoring in respect of the Purchaser; and
 - f. Deliver documents and/or notices to the Purchaser.

- d. Persons to whom the Company cedes its rights and/or delegates its obligations in terms of this Agreement; and
- e. Contractors and/or employees of the Company who are required to be informed of the personal information to enable the Company to comply with any quotation to and/or agreement with the Purchaser in respect of goods.

7. The Purchaser acknowledges and confirms that the Company may process their personal information using automated means (without human intervention in the decision-making process) so as thereby to make a decision about the Purchaser, including about the Purchaser's request for credit facilities with the Company.

The Purchaser acknowledges and confirms that they may:

- a. Access the information that the Company has about them and may request the Company to correct and/or delete the information if it is inaccurate, irrelevant, excessive, out of date, incomplete, misleading, and/or no longer authorized to be kept, and may file a complaint with the Information Regulator established in terms of the POPI Act about an alleged contravention of the protection of their information; and
- b. Withdraw their consent which allows the Company to process their information, except if otherwise allowed, and/or required by law.
